CONSENT JUDGMENT

UPON THIS MATTER coming up for hearing and determination in this Honourable Court before His Worship Nneka Eze-Obuzor Esq. Senior Magistrate sitting at Small Claims Court 4 Port Harcourt, and after hearing the application of D. P. Ojule, Esq. for claimant, M. C. Osuji, for the defendants.

IT IS HEREBY ORDERED AS FOLLOWS:

1. The defendants shall pay the claimant the sum of Six Hundred and Thirty One Thousand, Four Hundred and Twenty Six Naira only (N631,426) being the amount owed for the pharmaceutical products supplied by the claimants.
2. The defendants shall pay an additional sum of One Hundred Naira (N100,000) being the cost of litigation.
3. That the payment referred to in the above mentioned paragraph shall be made in six (6) installments as follows:
 - a. The first installment being a deposit for the sum of Thirty Thousand Naira (N30,000) only has been paid on the 28th day of February, 2023.
 - b. The second installment of Fifty Thousand Naira (N50,000) only shall be paid on or before 30th day of March, 2024.
 - c. The third installment of Eighty Thousand Naira (N80,000) shall be

- paid on or before 30th day of May, 2024.
- d. The fourth installment of Eighty Thousand Naira only (N80,000) only shall be paid on or before 30th day of May, 2024.
 - e. The fifth installment of Ninety One Thousand, Four Hundred and Twenty Six Thousand Naira (N91,426) only on or before the 30th day of June, 2024.
 - f. The sixth and final installment of Three Hundred Thousand Naira only (N300,000) and the additional sum of One Hundred Thousand Naira (100,000) as cost of litigation shall be paid on the or before 30th day of July, 2024.
 - g. That the said payments shall be made through the bank account of the claimant as provided below,

 - h. That the receipts of payment of each installment shall also be forwarded to the claimant's counsel.
 - i. That the defendants undertakes to adhere to the terms of settlement.
 - j. That in the event that the defendants defaults or fails to adhere to these terms of settlement, the claimant reserves the right to proceed with the execution of Judgment against the defendants.
 - k. That parties have agreed that the terms of settlement be entered as consent judgment of the court in this matter.
