CONSENT JUDGMENT

Facts

The claimant filed this suit against the defendant, claiming that on the 11th July, 2024, the sum of N169,445.00 (One Hundred and Sixty-Nine Thousand, Four Hundred and Forty-Five Naira) only, was withdrawn from her account without her consent, she banks with UBA, her account number is 2129177892, Wali Okagwa patience.

She prayed the Court to get her money back and for damages of N1,500,000.00 (One Million, Five Hundred Thousand Naira) only, as compensation. See Form RSSC 2 the complaint form.

On the 30th October, 2024, C. O. Ojirevwe appeared for the claimant while .W. Akaniwo-Chinwe (Mrs) appeared for the defendant, the Defence Counsel entered a plea of not liable for the defendant, the Court granted leave to both parties to settle out of Court amicably. The case was thus adjourned to 13th November, 2024 for Report Of Settlement.

COURT

Today, the Court was informed by both the claimant's counsel, C. O. Ojirewwe and .W. Akaniwo-Chinwe (Mrs) for the defendant, that parties had settled and filed their terms of settlement, before the Court dated 7th November, 2024 and filed 8th November, 2024, signed by both parties and their respective counsels, the terms of settlement are as follows;

1. The defendant will credit the sum of N169,445.00 (One Hundred and Sixty-Nine Thousand, Four Hundred and Forty-Five Naira) only, to the claimant's account number: 2129177892 domiciled with the defendant, being the sum wrongly deducted from the claimant's account on the 11th July, 2024 by an unknown person.
2. That the refund will be made on or before seven (7) days' after the consent judgment is entered.

The Court accordingly adopts same as its consent judgment.

This is the Consent Judgment of the Court.
